The company controls four subsidiaries: BMS (Pty) Ltd, Office Technique (Pty) Ltd, RangeCom (Pty) Ltd and Hybrid Systems (Pty) Ltd. e-Africa Holdings Limited was registered as a public unlisted entity in 2000 with the objective of acquiring viable companies as assets.

BMS celebrated its 50th anniversary in 2021 and has expanded to be a leading supplier of stationery, paper, office equipment, school uniforms, professional photography and office furniture to retail and corporate clients. The company has nine branches which have fully equipped digital printing centres that offer a complete range of printing services.

OFFICE TECHNIQUE is the exclusive distributor and authorised service provider for Konica Minolta devices in Botswana and trades as Konica Minolta Botswana. The company supplies industrial imaging products, including copiers, laser printers, multifunctional peripherals (MFPs) and digital print systems for the production printing market.

RANGECOM is involved in the wholesale distribution of various office brands. The company operates as a distributor, importer and exporter for almost every aspect of office requirements. The centre is also the focal supply point of BMS products and services and the company's expanding manufacturing hub, housing manufacturing services such as school uniform and till roll manufacturing.

HYBRID SYSTEMS specialises in access control, CCTV and asset tracking equipment and services. The company provides secure high definition surveillance for companies and security equipment with enhanced remote identification, consistent coverage and long distance monitoring.

TILL ROLL MANUFACTURING

BMS has been locally manufacturing thermal and point of sale till rolls for retail stores since 2020 and has received BOBS accreditation, as well as certification to use the Botswana pride mark on manufactured till rolls. BMS was also part of the board secretariats in the development of the BOS 859:2022 till roll standard gazetted in October 2022.

SCHOOL UNIFORM MANUFACTURING

BMS runs a successful digital trade platform selling 'Back to School' products including stationery and uniforms. BMS successfully handles the sale and production of school uniforms for various schools establishing its own uniform manufacturing production line in its distribution warehouse. The uniform manufacturing industry is regulated and licenced with skilled textile and operations employees. School uniforms are currently manufactured locally for more than ten schools in Botswana. Some of the company's short term goals are to roll out sublimation and digital to print machine services.
